Registering with the FCC and Applying for an FCC Registration Number (FRN)

1. In order to apply for an amateur radio license, you must first have an FCC Registration Number (FRN).

2. To apply for an FRN you must first register with the FCC. Go to the <u>CORES website</u> or copy and paste this URL into your bowser: https://apps.fcc.gov/cores/userLogin.do

2.2. Click on "**REGISTER**" just above the red arrow and you will be asked to provide the following information:

2.2.1. Enter Username and Password

2.2.1.1. Username. Enter a valid email address.

- This email address will be used as your username when logging in to the FCC User Registration System and other systems using an FCC Username Account.
- Any notifications relating to your Username Account will be sent to the email address provided.
- 2.2.1.2. Password
 - The password must be 12 to 15 characters long, cannot include any part of your Username, and must meet all the following criteria: 1 lower case letter, 1 upper case letter, 1 number, and 1 punctuation mark/special character.
- 2.2.2. Enter Additional Contact Information
 - 2.2.2.1. Name
 - Secondary e-mail (optional) The secondary email address provided cannot be used for login purposes.

- 2.2.3. Enter a Personal Security Question (PSQ) and Answer

2.2.4. Click on "Create Account"
